SCENTRAL BARK DOG PARK RULES

The following regulations apply at the Scentral Bark Dog Park:

1. Owners are legally responsible for their dogs and any injuries or damages caused by their dogs.
2. All dogs must be licensed per Section 174.07 Wisconsin Statutes.
3. If your dog is not neutered or spayed enter at your own risk.
4. Dogs under the age of 4 months are encouraged to use the small dog area.
5. Dog feces (and/or dog waste) must be cleaned up and properly disposed of by owners immediately.
6. All dogs must be on a leash until inside the fenced area.
7. Dog owners must carry a leash at all times, closely supervise their dogs and at no time may the owner leave the fenced area without his/her dog.
8. Owners are allowed a maximum of 2 dogs in the park at a time.
9. Gates must be closed except when entering or exiting the off-leash area.
10. Dogs must wear a current rabies vaccination tag.
11. Dogs must be under voice control at all times. Owners must stop dogs from digging and must fill any holes caused by their dogs.
12. Pinch, spike, choke and shock collars must be removed prior to entering the fenced off-leash area.
13. Agility equipment is to be used by dogs only.
14. Children under the age of 16 must be with an adult.
15. No one may conduct any kind of commercial or professional business in the dog park without approval from the Sauk Prairie Recreation Commission.
16. No climbing on or over the fence.
17. No vaping, smoking or tobacco use inside the fenced area.

The following are not allowed in the fenced area of the dog park:

1. Dogs in heat.
2. Aggressive dogs or dangerous dogs as defined in the Municipal Code.
3. Dogs that are ill or injured.
4. Animals other than dogs.
5. Alcoholic beverages.
6. Food, dog treats, rawhide or glass containers.
7. Bicycles, strollers, skateboards, roller skates or blades, or any motorized vehicles, except wheelchairs.

The word "owner" applies to the adult person accompanying the dog(s). A dog owner who fails to comply with the above rules may be asked to leave the dog park and may have their membership revoked.

Acceptance of Risks and Release of Liability

Acceptance of Risk and Release of Liability Acceptance of the terms and conditions of this release and adherence to dog park rules are conditions of membership approval, retention, and renewal for the Scentral Bark Dog Park, hereinafter referred to as the dog park. The Sauk Prairie Recreation Commission hereinafter referred to as SPCRD, may revoke membership at any time for non compliance.

I hereby acknowledge that I have voluntarily applied to participate and use, with my dog(s), the dog park area operated by SPCRD. I understand that (1) unleashing my dog and being physically present at a dog park area involves risks of injury to me, any individual(s) accompanying me or my dog(s), other people, and other dog(s), including but not limited to, risks resulting from aggressive dogs, unpredictable behavior, and lack of training; and (2) that despite the efforts of SPCRD to ensure owners have complied, there is a risk that not all dogs present in the dog park are licensed and vaccinated, which could result in injury to human or dog; and (3) SPCRD does not guarantee that dogs in the park are safe or healthy; and (4) additional risks include, but are not limited to, escape over and under fences, high-speed traffic on a highway immediately adjacent to the dog park, dog fights, dog bites, theft, disappearance or unlawful capture of dogs, being knocked down, chased or tripped by a dog, vegetation or standing water that may be unhealthy if consumed, and (5) use of the dog park is self-directed and not directly supervised by an agent of SPCRD, and (6) any violation of these terms, conditions, rules and regulations may result in suspension or revocation of membership and/or dog park privileges.

I further acknowledge that I (1) have carefully read this release of liability and understand it fully, and (2) agree with, and accept its terms and conditions; and (3) have received a copy of the rules for dog park usage and agree to abide by these rules and to inform others I bring into the dog park, including supervised children ages 15 and below, and anyone who brings my dog into the dog park, including children 16 and older, of these rules and will ensure their compliance with the rules; and (4) agree to immediately report any unsafe property conditions to SPCRD and (5) am not aware of any instance in which the dog(s) I am requesting an annual permit for has shown aggressive fighting or biting behavior towards other animals or people.

I assume all risks associated with using the dog park, including its fixtures and equipment, in an unsupervised manner, including the risk of injury to me, any individual (including supervised children 15 years and younger) accompanying me and/or accompanying my dog(s), or to my dog(s). In consideration

of SPCRD permitting me to use the dog park, I hereby fully and forever release and discharge SPCRD and the Village of Prairie du Sac and their elected officials, officers, employees, volunteers, and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of use or intended use of said dog park and off-leash area premises by me, any spouse or children of mine, my dog(s) or anyone accompanying me or my dog(s) pursuant to my membership. I fully and forever release

and discharge SPCRD and its elected officials, officers, employees, volunteers, and agents from any and all negligent acts and omissions in the same, and intend to be legally bound by this release.

I hereby assume sole responsibility for and agree to indemnify, hold harmless and defend SPCRD and the Village of Prairie du Sac, their elected officials, officers, employees, volunteers, and agents (the Indemnified Persons) from and against any and all claims (including for bodily injury, death or other damage) and demands, litigation, judgments, settlements, costs, and expenses (including reasonable cost of investigation, court costs and reasonable legal fees, expert fees, and other expenses), naming or in any way involving any Indemnified Person, to the extent it results or arises from use of the dog park by me or any person or dog under my supervision or present in the park pursuant to my membership, or any breach of this release or dog park rules by me or any such person or dog. If any circumstance shall arise in which any Indemnified Person is entitled to indemnity or defense pursuant to this release, I agree that upon written notice thereof I shall immediately assume the defense thereof, including the employment of counsel. The Indemnified Person(s) shall have the right to employ separate counsel in any such action and participate in the defense thereof, and the fees and expenses of such counsel shall be at their own expense.

I have carefully read this release of liability and understand and fully agree with its contents. I agree to obey and enforce all rules of the dog park.
